Introduction

The following memo outlines the safety actions that form the *Vision Zero Webb Laredo Safety Action Plan*. The action items are drawn primarily from stakeholder workshops held in April 2024 and amended based on Toole Design's national experience in writing proactive, comprehensive, and equitable safety action plans. Some actions have been reviewed, edited, and formatted based on staff judgement and discussion. Several actions were inserted based on identified gaps in project development, enforcement, and program development.

The list is structured within relevant framework for Vision Zero actions – including the Safe System Approach as well as the Vision Zero Network's "Vision Zero Community Components" and National Complete Streets Coalition "Complete Street Policy Elements." This list will be reviewed by plan stakeholders and incorporated into the final Safety Action Plan to guide future actions within the region.

Action Items Background

Frameworks for Vision Zero Actions

Safe Systems Approach

The Federal Highway Administration (FHWA) has adopted the "Safe System Approach" (SSA) for traffic safety. The SSA is a comprehensive paradigm that addresses decisions and outcomes in transportation safety by recognizing that: Humans Make Mistakes; Humans Are Vulnerable; Responsibility is Shared; Safety is Proactive; Redundancy is Crucial.

The Vision Zero Webb Laredo Safety Action Plan will develop action strategies that are consistent with the Safe System Approach focus areas:

- Safer People: encourage safe, responsible driving and behavior by people who use our roads and create conditions that prioritize their ability to reach their destination unharmed.
- Safer Roads: design roadway environments to mitigate human mistakes and account for injury tolerances, to encourage safer behaviors, and to facilitate safe travel by the most vulnerable users.
- Safer Vehicles: expand the availability of vehicle systems and features that help to prevent crashes and minimize the impact of crashes on both occupants and non-occupants.
- Safer Speeds: promote safer speeds in all roadway environments through a combination of thoughtful, equitable, context-appropriate roadway design, appropriate speed-limit setting, targeted education, outreach campaigns, and enforcement.
- Post-Crash Care: enhance the survivability of crashes through expedient access to emergency
 medical care, while creating a safe working environment for vital first responders and preventing
 secondary crashes through robust traffic incident management practices.

Vision Zero Community Components

The Vision Zero Network identifies nine elements that make a strong Vision Zero community:

- Political Commitment
- Multi-Disciplinary Leadership
- Action Plan
- Equity
- Cooperation and Collaboration
- Safe System Approach

- Data-Driven
- Community Engagement
- Transparency

Complete Street Policy Elements

The National Complete Streets Coalition recognizes ten principles of effective Complete Street Plans:

- Establishes commitment and vision
- Prioritizes underinvested and underserved communities
- Applies to all projects and phases
- Allows only clear exceptions
- Mandates coordination
- Adopts excellent design guidance
- Requires proactive land-use planning
- Measures progress
- Sets criteria for choosing projects
- Creates a plan for implementation

These frameworks have several common themes that can help identify practical, strategic, and effective strategies to achieve Vision Zero in the City of Laredo and Webb County:

- Building a sustainable program through vision, commitment, leadership, and staff capacity
- Collaborating with partners and the community, especially with a focus on equitable outcomes
- Planning that is proactive, data-informed, comprehensive, and transparent
- Projects that are strategic and multimodal throughout their lifecycle
- Monitoring and measuring progress and adapting strategies if necessary.

Assumptions

Safety Action Plans aim to be strategic and comprehensive but are by necessity high-level to cover a wide range of agencies, roles, and processes. The *Vision Zero Webb Laredo Safety Action Plan* items are intended to:

- Be short, concise, direct actions that can be advanced by several partners.
- Support the Safe System Approach and strategic, prioritized actions.
- Defer to staff and local knowledge for specific process or policy mechanisms.

Action Items Development

The Safety Action Plan action items listed below were developed through several rounds of stakeholder input and subject matter expert discussions.

A public open house was held on April 23, 2024 and an initial stakeholder workshop was held on April 24, 2024 at the Laredo Health Department. Stakeholders invited from local, regional, and state agencies, as well as key citizen stakeholders, participated in roundtable discussions related to the questions below. The responses from the open house and workshop informed the initial action items.

Overview of SSA: The workshop opened with a discussion of the **Safe System Approach** as a mindset that deaths and serious injuries are unacceptable on our roads. The approach acknowledges that road users are human beings and that humans will inevitably make mistakes. On the roads, those mistakes may lead to crashes. The goal of "zero" is to eliminate fatal and serious injuries, not to eliminate crashes.

Discussion Groups: Attendees were divided into small groups organized by expertise or agency roles in three categories.

- Safe Road Users: participants with roles related to helping to educate and illuminate people to become safer road users.
- Safe Roads: participants with roles related to making traffic operations, visibility, and physical infrastructure safer.
- Post-Crash Care: participants with roles related to emergency response, EMS, and ER preparedness.

Roundtable Questions: Stakeholders participated in two rounds of discussions facilitated by Vision Zero team members.

- Session 1: Internal Operations This discussion focused on participants' current and potential roles related to their discussion group's expertise. This discussion included actions that can be taken internal to their role and the people they work with.
 - 1. What is working well? What is not working or what challenges are you currently facing?
 - 2. What additional information do you need?
 - 3. What are the primary items we should be focused on internally in the near term?
- Session 2: Collaboration This discussion focused on how participants' current and potential roles
 can be enhanced through collaboration. This discussion helped identify collaborative actions that
 enhance their respective roles.
 - 4. What responsibilities do we share? What do you need from other agencies or departments?
 - 5. What are concrete examples of ways we can work better together?
 - 6. How do we decide what is most important? What should we prioritize first?

Additional Review: Following the stakeholder workshop, Vision Zero team members reviewed action items against public input from project open houses and online input, peer regions and national best practices, local equity concerns, and potential gaps from stakeholder discussions. The draft actions below underwent several rounds of review and revision to reach the current list. Draft actions will be circulated to agency stakeholders in late 2024 and early 2025 for review, concurrence, and incorporation into the final plan.

Action Plan Descriptive Elements

The Safety Action Plan actions should be seen as general recommendations. For project and construction actions, implementation would only occur where appropriate based on further analysis, engineering design, and environmental assessment. Other institutional or process actions may require policy changes in alignment with agency rules, regulations, and broader goals. Due to staffing, financial, and other constraints, SAP partners will need to consider how to prioritize implementation of these Actions in support of Vision Zero.

Each action will be assigned a rough estimate of time to implement, cost to implement, additional resources that may be required, and leadership to advance:

- Action items: A discrete, specific effort that can be advanced by a Vision Zero partner or in collaboration between several partners.
- Action Category: A specific program area that broadly aligns with a typical planning, coordination, funding, project development, and project delivery process.
 - Establish a Program
 - Work Together
 - o Inform with Data
 - Make Streets Safe
 - Protect Everyone
 - Measure Progress
- **Timeframe:** A general timeframe for actions to help action leaders prioritize their efforts. While some actions may take longer to implement, many medium- and long-term efforts can start immediately.

Immediate: 0-1 year
Short: 1-2 years
Medium: 2-5 years
Long: 5-10 years

- Cost: An anticipated annual cost level listed with each step based on the following ranges:
 - \$ low (less than \$100k)
 - \$\$ medium (between \$100k-\$500k)
 - \$\$\$ high (\$500k and above)
- Major Needs: Necessary components that need to be in place to help support a specific action:
 - o **Staffing –** an appointed staff or additional staff to lead or complete the task.
 - Study a specific additional study is needed to determine implementation factors.
 - Partnership a specific partnership between funding or decision-making agencies.
 - o **Policy** enabling legislation or policy to support a specific decision or action.
- Action Leader and Supporting Partners: Each action item is led by an action leader or lead partners and supported by various agencies or organizations.
